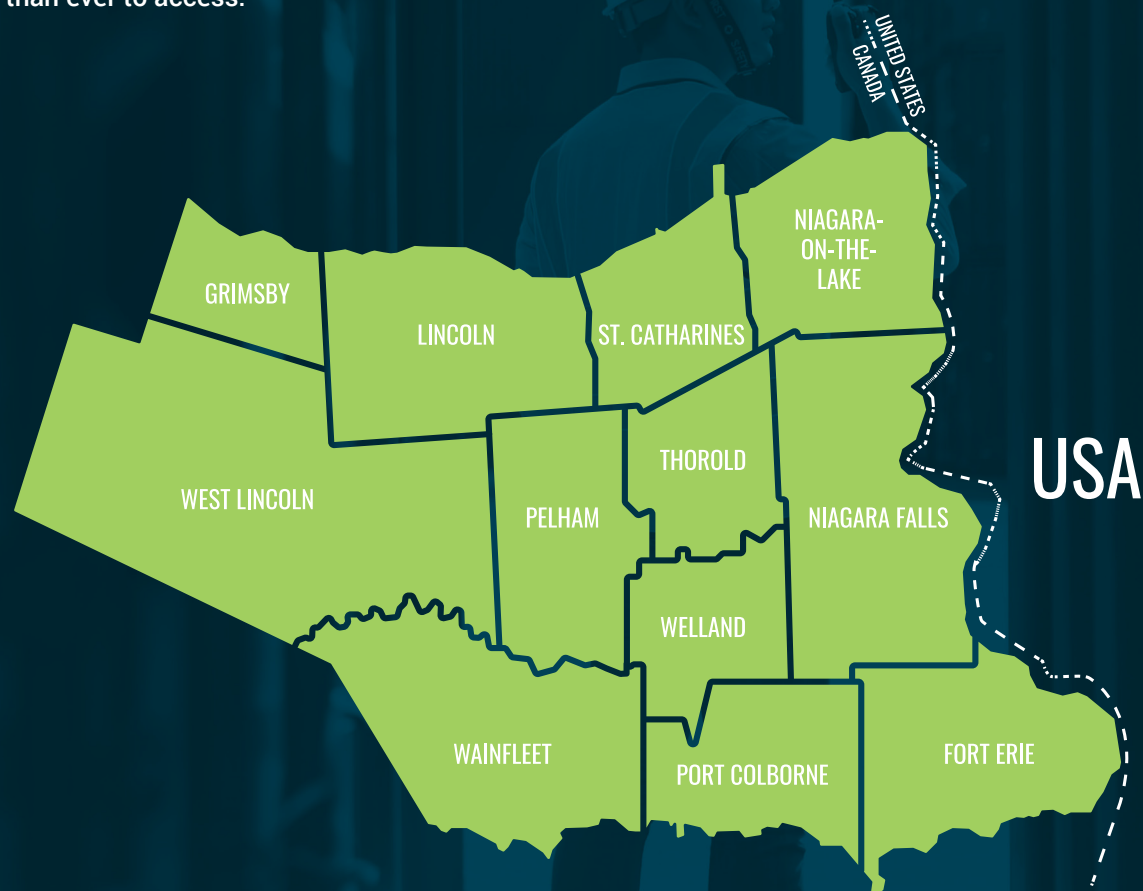

INCENTIVE PROGRAMS THE FOUNDATIONAL 5

NIAGARA BUSINESSES CAN LEVERAGE FIVE CORE PROGRAMS to save working capital and time spent on unnecessary transactions:



DUTIES RELIEF PROGRAM

Does your business import goods in Canada that are either stored, processed or used to create other goods before re-exporting them? This program can save you customs duties on those goods.



DRAWBACK PROGRAM

Does your business import goods that are later re-exported or destroyed under CBSA supervision? This program allows your business to apply for a refund of customs duties.



CUSTOM BONDED WAREHOUSE PROGRAM

Does your business ever store imported or domestic goods destined for export in a private or public customs bonded warehouse, office building, convention centre or hotel conference room? This program can save you customs and other import duties and taxes, including GST.



EXPORT DISTRIBUTION CENTRE PROGRAM

Does your business store or process imported goods and add limited value to them prior to re-export? This program could save you the GST/HST on imported goods and some domestic goods.



EXPORTERS OF PROCESSING SERVICES PROGRAM

Are you a non-resident that imports goods for processing, distribution or storage that are subsequently exported? This program could save you the GST/HST on those goods.
