






Niagara is one of North America's busiest economic trade corridors. Via road, rail, sea and sky, over \$100 billion in trade flows across Niagara's borders each year.



Niagara's four 400-series highways and multiple international bridge crossings into the U.S. play a critical role in the shipment of goods in and out of the region. Over a million trucks, or 1 of every 6 trucks that cross between Canada and the U.S., go through Niagara's borders.



Niagara has two Class One railroads with border crossings. The CN and CP tracks offer another affordable alternative for shipping products on land.





Niagara is the busiest border crossing zone for people and the second-busiest in terms of the overall value of goods crossing regional borders.

#### 5. PEACE BRIDGE, FORT ERIE - RAIL



The Welland Canal is a critical section of the St. Lawrence Seaway System and plays a key role in the transport of goods between the American Midwest and the Atlantic Ocean. Its eight locks allow ships to bypass Niagara Falls to make their way between Lake Erie and Lake Ontario. Approximately 78% of the St. Lawrence Seaway System's freight travels up or down the Welland Canal, driving \$276 million in economic activity within Niagara.

Niagara also offers close proximity to the Port of Hamilton, which is Ontario's largest port with \$6 billion in economic activity.





For businesses that depend on air travel for the movement of people and product, Niagara has multiple airport options within a 100-km radius.

# **INCENTIVE PROGRAMS**



In addition to helping businesses tap into numerous provincial and federal funding programs, the Niagara Economic Development team works closely with its municipal government partners to provide a range of generous financial incentives to developers, investors and business owners. Many of these programs are linked with existing property inventories to assist in site selection decisions and program applications.

#### **NIAGARA GATEWAY ECONOMIC ZONE AND CENTRE COMMUNITY IMPROVEMENT PLAN** (GATEWAY CIP)

Receive property tax reductions of between 40% and 100% for five to ten years and grants toward Regional Development Charges for eligible projects in Fort Erie, Niagara Falls, Port Colborne, Thorold and Welland.

#### **BROWNFIELD INCENTIVES**

Receive tax freezes, environmental study grants and rebates to help offset increases in property taxes for the redevelopment of one of Niagara's Brownfield sites.

#### **DEVELOPMENT CHARGE INCENTIVES**

Receive up to a 100% reduction in Development Charges for the development or redevelopment of Niagara's central urban areas, local Community Improvement Project areas and Brownfield sites.

#### **OTHER INCENTIVES**

Access concierge-style support to research and apply for other municipal, regional, provincial and federal programs that can drive significant savings for residential, commercial, industrial or agricultural projects in Niagara.


